## ENVIRONMENTAL IMPACT STATEMENT ORGANIZATION

This Environmental Impact Statement (EIS) describes the anticipated impacts of the disposal and reuse of Fort McClellan, Alabama. It identifies and describes the proposed actions, alternatives to these actions, and related environmental effects as required by the President's Council on Environmental Quality regulations, the National Environmental Policy Act and Army Regulation 200-2. The main body of the EIS consists of one volume (Volumes I). In addition, Volume II contains appendices that include supporting documents and other relevant information.   - Section 6   **LIST OF PREPARERS** identifies the professional and technical staff responsible for the preparation of the EIS, and provides a summary of their qualifications.
  - Section 7   **DISTRIBUTION LIST** identifies public officials, public agencies, public interest groups, organizations, and individuals that received copies of the EIS.
  - Section 8   **INDEX** provides an alphabetical list of topics addressed in the EIS.
  - Section 9   **REFERENCES** provides a listing of materials used in the development of the EIS.
  - Section 10   **PERSONS CONSULTED** identifies public agencies, public interest groups, organizations, and individuals that were consulted during the development of the EIS.
- LIST OF ACRONYMS AND ABBREVIATIONS** provides a fold out list of abbreviations and acronyms used in the EIS.
